



DESCRIPTION / APPLICATIONS

The VS-UFB280FA20 insulated modules integrate two state of the art ultrafast recovery rectifiers in the compact, industry standard SOT-227 package. The diodes structure, and its life time control, provide an ultrasoft recovery current shape, together with the best overall performance, ruggedness and reliability characteristics.

These devices are thus intended for high frequency applications in which the switching energy is designed not to be predominant portion of the total energy, such as in the output rectification stage of welding machines, SMPS, DC/DC converters. Their extremely optimized stored charge and low recovery current reduce both over dissipation in the switching elements (and snubbers) and FMI/RFI.




Fig. 1 - Typical Forward Voltage Drop Characteristics (Per Diode)




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 4 - Maximum Thermal Impedance Z_{thJC} Characteristics (Per Diode)




Fig. 5 - Maximum Allowable Case Temperature vs. Average Forward Current (Per Leg)




Fig. 6 - Forward Power Loss Characteristics (Per Leg)




Fig. 7 - Typical Reverse Recovery Time vs. dl_F/dt




Fig. 8 - Typical Stored Charge vs. dl_F/dt





Fig. 9 - Reverse Recovery Parameter Test Circuit

$$Q_{rr} = \frac{t_{rr} \times I_{RRM}}{2}$$








SOT-227 Generation II
